DIRECTIVE ON STUDENT ADMISSION TO UNDERGRADUATE PROGRAMS FROM
ABROAD

(Accepted by the Senate decision dated 09.07.2024/06-19)

CHAPTER ONE
Purpose, Scope, Basis and Definitions

Purpose

ARTICLE 1- (1) The purpose of this directive is to determine the procedures and principles regarding the admission of international students to Yıldız Technical University undergraduate programs.

Scope

ARTICLE 2- (1) This directive covers the application and registration procedures of international students to Yıldız Technical University undergraduate programs.

Basis

ARTICLE 3- (1) This Directive has been prepared based on Article 45 of the Higher Education Law No. 2547, which was amended in accordance with Article 14/f of the Law No. 6287 on the Amendment of the Primary Education and Education Law and Certain Laws published **in the Official Gazette dated 11.04.2012 and numbered 28261**, and the "Principles Regarding the Admission of Students from Abroad" determined by the Council of Higher Education.

Definitions

ARTICLE 4- (1) In this Directive;

- a) Candidate: International student applying to units affiliated to Yıldız Technical University,
- b) Apostille: It is a document approval system that certifies the authenticity of a document and allows it to be used legally in another country.
- c) Presidency: Yıldız Technical University Registrar's Office,
- ç) Unit: Faculties affiliated to Yıldız Technical University,
- d) Student: International student whose applications are accepted to the units affiliated to Yıldız Technical University,
- e) Program: Programs that carry out educational activities at the undergraduate level,
- f) Rector: The Rector of Yıldız Technical University,
- g) Senate: Yıldız Technical University Senate,
- ğ) University: Yıldız Technical University,
- h) Board of Directors: Yıldız Technical University Board of Directors

CHAPTER TWO

Principles Regarding Application

Making Applications

ARTICLE 5- (1) The necessary conditions for the application are announced on the website of the University and applications are made online.

(2) Candidates can make a maximum of 5 choices in applications and placement is made according to the preference priority of the candidate.

General Requirements for Application

ARTICLE 6- (1) Candidates who have graduated from secondary education institutions whose equivalence has been approved by the competent authorities at the high school level or who are studying in their last year of high school can apply to undergraduate programs.

(2) Candidates who provide sufficient points from any **of the exams** or diploma types specified in the additional list (Annex-1) can apply to undergraduate programs.

(3) Applicants to programs with special entry requirements must meet these requirements in addition to the admission requirements.

Candidates whose applications will be accepted

ARTICLE 7- (1) Candidates who meet the following conditions can apply, provided that they are in their last year of high school or have graduated:

- a) **Foreign nationals (provided that** they are studying / not graduating from secondary education (high school) institutions in Turkey [except for embassy schools, international private education institutions in the MOBIS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education])
- b) **Those who are Turkish citizens by birth but have lost their Turkish citizenship by obtaining permission from the Ministry of Interior to renounce Turkish citizenship, and those who certify that they have a blue card, which is given to those who have lost their Turkish citizenship upon their request** (provided that they are not studying / graduating from secondary education (high school) institutions in Turkey and the TRNC) (Article 7 of the Turkish Citizenship Law No. 5901). There is a provision in the article "(1) A child born in a marriage union to a Turkish citizen mother or father in or outside Turkey is a Turkish citizen." and it is useful for candidates who will apply for admission quotas from abroad to examine the Turkish Citizenship Law.)
- c) **Those who have acquired Turkish citizenship with the citizenship acquired later while being a foreign citizen / dual nationals in this situation** (provided that they are studying / not graduating from secondary education (high school) institutions in Turkey and the TRNC)
- d) **Those who are Turkish citizens and have completed their entire secondary education (high school) in a foreign country other than the TRNC** (including those who have completed their entire secondary education [high school] in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC)
- e) **TRNC nationality** ; Those who reside in the TRNC and have completed their secondary education (high school) in the TRNC and have GCE AL exam results, and those who have enrolled and studied in colleges and high schools in other countries between 2005-2010

and have / will have GCE AL exam results, or those who are TRNC citizens and have completed their entire secondary education (high school) in a foreign country and have TR-YÖS results.

Acceptance of applications,

Candidates whose applications will not be accepted

ARTICLE 8- (1) Candidates who meet the following conditions cannot apply:

- a) **Those who are Turkish citizens and have completed their entire secondary education (high school) in Turkey or the TRNC,**
- b) **TRNC citizens** (except those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results, and those who have enrolled and studied in colleges and high schools in other countries between 2005-2010 and have GCE AL exam results, or those who are TRNC citizens and have completed their entire secondary education (high school) in a foreign country and have TR-YÖS results),
- c) **7. Dual nationals whose first nationality is T.R. by birth as defined in subparagraph (b) of paragraph 1 of Article 7,** (7. Except for those who meet the conditions in subparagraph (d) of paragraph 1 of the article)
- d) **Dual citizenship, one of which is TRNC citizenship** (except those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results, and those who have enrolled and studied in colleges and high schools in other countries between 2005-2010 and have GCE AL exam results, or those who are TRNC citizens and have completed their entire secondary education (high school) in a foreign country and have TR-YÖS results),
- e) **Turkish citizens who are studying at schools within the embassies in Turkey and foreign high schools in Turkey or 7. Dual nationals whose first nationality is Turkish by birth as defined in subparagraph (b) of paragraph 1 of the article**
- f) **TRNC citizens who are studying/graduated from secondary education (high school) institutions in Turkey and the TRNC and those who have renounced Turkish citizenship/Blue Card holders**
- g) **Foreign nationals who are studying/graduated from secondary education (high school) institutions in Turkey** (except for embassy schools and international private education institutions in the MOBIS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education)

applications are not accepted,

Application Exam and Scores

ARTICLE 9- (1) Candidates who can be admitted to university programs **must get minimum scores** from national and/or international exams or diploma graduation degrees in Annex-1.

(2) The exams based on the application are valid for 2 (two) years, and the diplomas that have the status of high school graduation exams are valid indefinitely.

Documents Required for Application

ARTICLE 10- (1) All documents required for the application must be in Turkish or English. If the original copies of the documents are not in Turkish or English, a certified translation of the documents in Turkish or English must also be submitted in the application together with the originals of the documents.

(2) The documents required for the application are as follows:

- a) A certified copy of the high school diploma or an official document issued by the secondary education institution (high school) where the candidates who have not received their high school diploma are studying, showing the date of graduation,
- b) The original of the document showing the graduation grade point average and a certified copy translated into Turkish or English,
- c) Copy of the pages of a valid Passport showing identity information,
- d) **A notarized and approved copy of the exam result documents and scores (SAT, ACT, etc.) other than the TR-YÖS Exam Result Document specified in Annex-1,**
- d) Certified copy of diplomas recognized on a country basis obtained from Turkish Foreign Representatives.

CHAPTER THREE **Language of Instruction and Student Quotas**

Conditions of Instructional Language

ARTICLE 11- (1) (Amended: Senate No. 21.07.2025/07-08) Students who are admitted to programs that provide 100% Turkish education must obtain a Turkish Language Certificate at least C1 level to be issued by TÖMER or Yunus Emre Institute affiliated to our University within 1 (one) year from the date of registration. Those who cannot bring a Turkish Proficiency Certificate within this period are considered on leave for an additional 1 (one) year. Students who do not have a C1 level Turkish Proficiency Certificate cannot start their education at the University. The registrations of students who do not submit their Turkish Language Certificate to the University within the legal periods are deleted by the Registrar's Office.

(2) (Amended: Senate No. 21.07.2025/07-08) Students admitted to programs that provide 30% English education must obtain a Turkish Language Certificate at least at C1 level to be issued by TÖMER or Yunus Emre Institute affiliated to our University within 1 (one) year from the date of registration. Those who cannot bring a Turkish Proficiency Certificate within this period are considered on leave for an additional 1 (one) year. Students who do not have a C1 level Turkish Proficiency Certificate cannot start their education at the University, including English Preparatory education. The registration of students who do not submit their Turkish Proficiency Certificate to the University within the legal periods is deleted by the Registrar's Office. Students who prove their Turkish proficiency are exempted from English preparatory education, provided that they meet the conditions in Article 8 of the "Yıldız Technical University School of Foreign Languages Education and Examination Directive". Students who cannot meet these conditions are subjected to English preparatory education.

(3) (Amended: Senate No. 22.10.2025/10-06) Students admitted to programs that provide 100% English education must comply with Article 8 of the "Yıldız Technical University School of Foreign Languages Education and Examination Directive". Provided that they meet the conditions in the article, they are exempted from English preparatory education. Students who cannot meet these conditions are subjected to English preparatory education.

Students who are admitted to programs that provide 100% English education must obtain a Turkish Proficiency Certificate at least B1 level to be issued by TÖMER or Yunus Emre Institute affiliated to our University within 1 (one) year from the date of registration. Those who cannot bring a Turkish Proficiency Certificate within this period are considered on leave for an additional 1 (one) year. The registrations of students who do not submit their Turkish Language Certificate to the University within the legal periods are deleted by the Registrar's Office.

(4) (Amended: Senate No. 22.10.2025/10-06) Students admitted to the French Translation and Interpreting program, which provides 100% French education, are exempted from French preparatory education, provided that they meet at least one of the following conditions:

- a) Applicants to the French Translation and Interpreting Program must be successful in the French Proficiency Exam (FYS) conducted by the relevant program,
- b) To graduate from private French high schools or Turkish high schools that provide French preparatory education,
- c) Who have received at least 70 and above points from YDS, e-YDS, YÖKDİL exams, which are accepted as equivalent to FYS, within the validity period,
- d) To have received at least B2 from the International DELF Exam, which is considered equivalent to the FYS, and C1 or C2 from the DALF Exam (without time limitation),
- e) To get a score of 70 or more out of 100 from the Foreign Language Placement Exam (YDS) exam conducted by the Assessment, Selection and Placement Center and to document this situation,
- f) Have a French Baccalaureate.

Students who are admitted to the French Translation and Interpreting program, which provides 100% French education, must obtain a Turkish Proficiency Certificate at least at C1 level to be issued by TÖMER or Yunus Emre Institute affiliated to our University within 1 (one) year from the date of registration. Those who cannot bring a Turkish Proficiency Certificate within this period are considered on leave for an additional 1 (one) year. The registration of students who do not submit their Turkish Proficiency Certificate to the University within the legal periods is deleted by the Registrar's Office.

(5) Turkish Proficiency Certificate is not required from TRNC students.

Student Quotas

ARTICLE 12- (1) The quotas to be allocated to the programs that accept international students and the special conditions, if any, are determined by the decision of the Senate. The quotas to be determined for teaching programs should not exceed 10% of the undergraduate student quota of the relevant year for the said program.

(2) The university is free to fill the announced quotas or not. Quotas can be transferred between programs when necessary.

CHAPTER FOUR

Evaluation, Tuition Fees and Registration

Evaluation

ARTICLE 13- (1) In the evaluation of the applications, based on the success of the candidate in national/international exams, **the scores obtained in the exam or diploma types** in Annex-1 are converted into a 100-point system with the formulation in Annex-2 and the ranking is made accordingly. In case of equality in the ranking, diploma grade and age are taken into account, respectively.

(2) Candidates who apply to programs that accept students with a special talent exam must also be successful in the Special Talent Exam to be held by the University.

(3) An acceptance letter is sent by the Registrar's Office to the e-mail addresses declared by the students admitted to the programs during the application.

Tuition Fee

ARTICLE 14 - (1) Pursuant to the provision of Article 46 of the Higher Education Law No. 2547 that "the amount of the minimum tuition fees to be collected from foreign students is determined by the decision of the President", students are charged tuition fees in the amount determined by the decision of the University Administrative Board and accepted by the Council of Higher Education, provided that they remain within the minimum and maximum limits determined every year by the Presidential Decree.

(2) Students are obliged to declare that they have sufficient financial livelihood security to continue their higher education and earn a living in our country by signing the Financial Security Declaration Form. (**Annex-3**)

(3) A financial security amount is determined by the Board of Directors in order to ensure that the financial means of the students coming from abroad enable them to continue their higher education in our country.

Registration

ARTICLE 15- (1) Registration procedures are carried out by the Registrar's Office. The documents required for registration are:

- a) The original of the high school diploma and its Turkish translation approved by the notary public or Turkish Foreign Representatives operating in Turkey with Apostille, **[Registration will not be made with the Graduation Certificate. However, in exceptional cases; Students who cannot receive their diplomas from the school they graduated from and apply with a temporary graduation certificate are required to bring the original of their diplomas by the end of the semester they are registered (the end date of the Fall semester specified in the academic calendar of the relevant academic year). The registrations of students who do not submit their original diplomas within this period are deleted by the Registrar's Office.]**
- b) For Turkish students who completed their high school education abroad; "Equivalence Certificate" to be obtained from the Embassies or Consulates of the Republic of Turkey or the Ministry of National Education of the Republic of Turkey, showing that the high school diploma is equivalent to the diplomas obtained from Turkish high schools, **[It is obligatory to bring the original of the Equivalence Certificate by the end of the semester in which it is registered (the end date of the Fall semester specified in the academic calendar of the relevant academic year). The registration of students who do not submit their diploma equivalence within this period is deleted.]**
- c) The original of the document showing the graduation grade point average and its Turkish translation approved by the notary public operating in Turkey or the Turkish Foreign Representatives,
- ç) The original of the exam result document to be used in the application and its notarized Turkish translation,
- d) Certified copy of the page of the identity document or passport showing the identity information,
- e) Receipt of payment of the tuition fee,
- f) "Student Visa" to be obtained from Turkish Foreign Representatives, **[Those who do not have a student visa must be in the status of foreigners who will not be required a Student Visa within the framework of the principles determined by the General Directorate of Security.]**
- g) 6 passport size photographs taken in the last 6 months,
- ğ) The original and certified copy of the valid Turkish proficiency certificate, if any, **[It is not required from students with Blue Card and Turkish citizenship. Foreign nationals (whose**

first nationality is not Turkish) studying high school in Turkey are required to bring a Turkish proficiency certificate.]

- h) Foreign National Identity Number (YU), if any,
- i) Certified Population Registration Copy for dual nationals who are foreign nationals by birth and later acquire Turkish citizenship,
- j) Financial Security Declaration Form,
- k) A document approved by the General Directorate of Security showing the entry/exit of Turkish citizens studying high school abroad,
- k) YTU International Student Registration Commitment Form.

(2) Students are required to register in the first semester they are admitted to the program. Students who do not register during the registration period are deemed to have waived their rights.

(3) In order for registered foreign students to reside in Turkey to study, they must obtain the student residence permit issued by the competent authorities of the Ministry of Interior within the framework of the provisions of the Law on Foreigners and International Protection No. 6458 within 90 (ninety) days and submit it to the Registrar's Office.

Registration Deletion

ARTICLE 16- (1) The registration of a student who does not pay the tuition fee and does not take courses for two consecutive years is deleted by the decision of the relevant faculty administrative board. (In accordance with the Higher Education Executive Board dated 27.12.2023)

CHAPTER FIVE

Miscellaneous and Final Provisions

Overseas Student Office

ARTICLE 17- (1) The Overseas Student Office within our university is responsible for preparing introductory documents and catalogs for our universities in order to enable students coming from abroad to choose the universities of our country in their preferences, to encourage the participation of our universities in education fairs abroad, and to assist the students who apply or come.

Cases Without Provision in the Directive

ARTICLE 18- (1) In cases where there is no provision in this Directive, the provisions of the "Principles Regarding the Admission of Students from Abroad Determined by the Council of Higher Education" and "Yıldız Technical University Undergraduate Education and Training Regulation" are applied.

Repealed Directive

ARTICLE 19- (1) The "Directive on Admission of Students to Undergraduate Programs from Abroad", which entered into force with the Senate decision dated 23.05.2023 and numbered 2023/05-06, has been repealed.

Enforcement

ARTICLE 20- (1) This Directive has been accepted by the University Senate dated 09.07.2024 and numbered 2024/06-19.

Execution

ARTICLE 21- (1) The provisions of this Directive are executed by the Rector.
